#### 1. Magam for Arabic Studies

#### Workshop led by Safaa Radoan (October 2022)

Teaching Foreign languages for Students with Visual Impairment: Practical tips for language teachers to help visually impaired students to maximize their performance in the language classroom.

#### **Research project** led by Giorgia Ferrari (October 2022)

Maqam is conducting an online survey to identify A1 and A2 Arabic grammar taught to AFL students in British, European and American Universities. The objective is to identify commonalities and differences in existing Arabic language programmes and to put together guidelines of grammar topics to be taught at the two beginners' levels, A1 and A2.

#### Field trip (December 2022)

Maqam is organizing the annual trip to the Bristol Palestine Film Festival. The trip includes Intermediate and Advanced Arabic students where they can watch Arabic speaking movies and participate in live discussions with acters and directors.

#### Field trip organized by Giorgia Ferrari (March 2023)

In partnership with <u>the Arab British Centre</u>, Maqam will be organising a trip to London to the centre in which Arabic language students take a two-hour practical lesson in Arabic on playing the Oud.

#### 2. Centre for the Study of Islam

The Centre for the Study of Islam had another very productive academic year, 2021 to 2022. Highlights included the visit of Professors Nahyan Fancy (de Paul) and Wahid Saleh (Toronto) to the Institute as Al-Qasimi visiting professors in Islamic Studies. Their presence in the Institute gave us new research perspectives and they enriched our seminars and workshops with their contribution. More specifically, they organised their own workshops, which were very well attended and which provided PhD students with the opportunity to meet and discuss their research with these leading scholars.

Our weekly seminars (on Wednesday lunchtimes) continue to prove popular throughout the year with PhD students, Postdocs and Staff presenting, as well as visiting scholars — these included presentations but also including the chance to read Arabic texts together. A new innovation for 2021-22 was the Monday majlis, an online meeting on a Monday late afternoon with international scholars presenting their latest research to an online audience.



Full details of these past activities are available on the CSI pages section of the IAIS website. We will be continuing these (and other) activities in the coming year.

We had some great application successes as well. Kumail Rajani who is able to secure a British Academy research fellowship for three years, beginning in January 2023. Robert Gleave was awarded a British Academy Wolfson professorship, also for three years, and also beginning in January 2023.

Critical to the CSI's success is the work of staff members – we particularly recognise the professional support given by Sarah Wood as CSI research officer. It simply would not happen without her dedication and enthusiasm. We were fortunate to have additional research fellows, in the form of Omar Anchassi, and Pooya Razavian. They were both attached to the LAWALISI project for a period of six months and left in February 2022. Davide Pettinato joined us as a postdoc focusing on Islam and environmentalism. Belal Alabbas, who has been the British Academy Newton International fellow for the past 2.5 years, has secured a teaching position at the University of Bristol, and so will leave the Centre for the Study of Islam at the end of September 2022 - we wish him all the best in his future endeavours. Raha Rafii, LAWALISI postdoc also ended her time at Exeter, also in February 2022 – and we wish her all the best for her future work. The LAWALISI project came to an end in August 2022, and Kumail Rajani, the last remaining postdoc, will be taking over teaching responsibilities until January 2023 when he starts his British Academy postdoctoral fellowship. The CSI also hosted the ISLE (Islamic Law on the Edge) project, jointly held by Rob Gleave and Shahanaz Begum – this included seminars in Exeter and Spain, and a week-long summer school in June with 15 students from around Europe working on Islamic legal studies.

Members of CSI have produced various articles, book chapters, and edited collections over the past year, and full details are available on the individual webpages of CSI members. The CSI activities for the academic year 2022 to 2023, are currently under development, and will be posted on the CSI webpages in the coming weeks.

Finally, we have a change of director, as Rob Gleave steps down to take up his Wolfson professorship, and István Kristó-Nagy takes over as the new Director.

We look forward to another productive year of CSI activities and as always, we welcome engagement and participation from colleagues across the university.

#### Professor Robert Gleave

The Centre for the Study of Islam (CSI) has been thriving through the past years mostly due to the immense amount of dedicated work invested in by the previous director, Professor Robert Gleave. The administrative help from Sarah Wood was also instrumental in this success. Professor Sajjad Rizvi the former Head of the IAIS and member of the CSI also played a key role in some of our activities, in particular the online series 'Exeter-Habib Conversations: conversations in Postcolonial Islamic Spiritualties'. As the Head of IAIS, Professor Rizvi advised me when I took over the directorship that it may be impossible to maintain the same intensity of the programme as we had it last year, which included roughly



three events each week. We agreed that we should aim to have at least one every fortnight, but I am aiming for significantly more.

We will maintain the following activities:

#### CSI Monday Majlis

The CSI Monday Majlis is an online event, where invited speakers present on aspects of their current research. This may be a book they have recently published, a new project they are working on, or an exciting new potential avenue of Islamic studies research. They take place Mondays, online 1700-1830 UK time.

I aim to have a speaker each week. I have started to organise them and I will chair them.

#### **CSI Wednesday Seminars**

A research seminar in person with CSI members (students, research fellows, permanent staff and the visiting Al-Qasimi professor) and visiting speakers introducing the latest CSI research. They are timetabled for 3pm-4.30pm in Lecture Theatre 2, IAIS building.

I aim to have a seminar each fortnight, but if we have enough students, staff members and visiting speakers to present more, we can have more. I will chair these, too. I have started to organise for visiting speakers (aiming to have two or more each term).

Professor William Gallois will present a series of 4 lectures titled *Lewisohn Lectures* in memory of our colleague Lenny Lewisohn on the theme of *'Rethinking Islamic art in the period 1880-1930 C.E.'*.

#### Hikma: Philosophy and Poetry in Islamic Thought

Professor Rizvi is organising a new online series called *Hikma: Philosophy and Poetry in Islamic Thought*, starting probably late September or early October, fortnightly, most probably on Thursday or Friday. They will be chaired by Professor Rizvi.

#### **CSI Research Afternoons**

We aim to have a research afternoon at the end of each term. These will be organised and led by a member of the CSI with one or more visiting speakers as well as speakers from the CSI. It is possible we will have more of these research afternoons, too. Dr Belal Alabbas is organising the first one, scheduled for the 28<sup>th</sup> of September 2022, on the topic of 'Hadith in Legal Theory', which will introduce, rather than conclude the activities of the CSI in the term and the academic year.

17 June 2022: We had the honour of welcoming IAIS alumnus Mr Tim Eaton (Chatham House). Tim gave a talk open to the public followed by a Q&A on the topic of 'Elite networks and state formation in Libya post-2011'.

#### Furthermore:

- · C-MEP assisted in the hiring process for the two new MERIP-related posts (MERIP is hosted by C-MEP).
- · We set up a C-MEP webpage.
- · C-MEP was scheduled to host a student-led international workshop on 'civil resistance', which was sadly postponed. The workshop is designed and will be delivered by Vito Morisco (IAIS PhD student) sometime in the coming academic year instead.
- C-MEP members (Prof. Storm, Dr Gao and Dr Brownlee) have been closely involved in a grant application process with other colleagues in Law and Politics. This is a large bid for a Global Centre for the Study of Authoritarianism (Pls: Dr Cat Owen (Exeter, Penryn) and Prof. Lise Storm (Exeter)).
- · C-MEP hosted an international webinar/talk/book launch organized by Dr Sabiha Allouche (Exeter, Penryn). The speakers were Prof. Carl Rommell (Texas), Prof. Nazanin Shakroni (LSE) and Dr Sabiha Allouche (Exeter, Penryn).

With the funds left over and the additional funds from the IAIS pot, C-MEP also sent 3 PhD students to BRISMES at St Andrews (4-6 July 2022). The students in question were: Hemn Seyedi, Peyman Zinati and Yunus Abakay. Students were asked to submit a proposal in November 2021.

I will only be directing CMEP in term 1 as I will be on leave in term 2. However, for term 1 I have a workshop on how to publish in MERIP lined up (hopefully October) and in November a workshop on how to publish with EUP. There will also be the regular meetings, of course. I have spoken with Ella, and it is likely that there will be two grant writing workshops in term 2, one with research support services and a second where people receive feedback on drafts/substantial ideas. There will also be monthly members' meetings in t2.

#### Kurdish Folklore as World Heritage: Language, Music, and the Archives

Organisers: University of Exeter (DAME & CKS), Jagiellonian University (Poland), Kurdish Heritage Institute (Iraqi Kurdistan), Mezopotamya Foundation (Turkey)

The oral stories and songs performed by traditional performers, *dengbêj* and *çirokbêj*, have been the site of knowledge, memory, history, as well as the main form entertainment in Kurdistan up until the 1970s. Kurdish intellectuals, activists and the modern institutions established in the fragile political environments of the "Middle East" have been acutely aware of the necessity of collecting, documenting, preserving, and studying the diverse oral tradition of the Kurds. However, their existence has been threatened by states' suppression and lack of funding. This international conference brings together the experience of Kurdish folklore collectors, archivists, international scholars, and institutions to explore possibilities of collaboration to study, develop and promote the diversity of Kurdish oral cultures. 




#### 7. Centre for Islamic Archaeology

We concluded our successful online Spring seminar series - **Medieval Archaeology** in the Horn of Africa with four further lectures co-organised and co-chaired by Awet. T. Araya and Timothy Insoll.







The semester 1 programme of the CfIA is dominated by our hosting the 2<sup>nd</sup> international conference, **Indian Ocean World Archaeology (IOW-ARCH)**, on the 19<sup>th</sup>-20<sup>th</sup> December 2022, here in the IAIS Building with papers encompassing the archaeology, material culture and heritage of the Indian Ocean (defined as from East Africa to Japan, including Australasia) from the first millennium BC to the contemporary era. This is a joint CfIA student-staff organised event and follows the very successful inaugural IOW-ARCH conference also held in the IAIS in January 2020.

#### Refurbished Basement Workroom – Opening Event – 21/10/22

The CfIA is delighted to welcome you to visit our refurbished workroom on **Friday 21**<sup>st</sup> **October from 1400-1800**. The work was completed as part of the basement renovations linked with the movement of AWDU back into the building and funded as part of the DAME project. This new space permits us to store securely for the first time all the equipment, archaeological materials and teaching collections used by the CfIA and provides a dedicated space for analysis and research by the CFIA PhD students and visiting researchers.

#### **Student News**

Two of our students have been successful in securing recently academic posts. Awet Teklehimanot Araya has been appointed as Project Curator: Africa in the Africa, Oceania, and America department at the British Museum, where he will be involved in two major Africa-focused exhibitions; refreshing the Africa (Sainsbury) gallery and the International Training Program (ITP). He will also be involved in various Africa linked projects of the museum, and Dr Nathan Anderson has been appointed as a temporary lecturer in Archaeology at Santa Clara University in California.

# Update on the DAME Project (Digital Archive of the Middle East), Special Collections and AWDU

Work continues on digitising selected material from the Arab World Documentation Unit (AWDU) and the Middle East archives held in Special Collections, and it is hoped that a dedicated digitisation space will shortly be established in the Old Library. Work has begun designing and constructing the DAME digital platform.

Three DAME PhD students will be starting this term, with research projects comprising 'The Roaring 70s: Cultural Renaissance in Iraqi Kurdistan', 'Reclaiming the Sea: coastal privatisation, land reclamation and contestation along Bahrain's shores' and '(De)Constructing Borders: A Digital Investigation of the Archaeological, Cultural, and Political Landscapes of Middle Eastern Nationhood.'

As part of her work for the Kurdish Digital Archive, Farangis Ghaderi has been in Kurdistan developing partnerships with a number of Kurdish archives - including both personal and institutional collections - museums and libraries. She hopes to provide a full report on her visit at the first DAME seminar, to be held in the autumn. Regular seminars will be held thereafter, allowing the PhD students and other researchers to present on different topics relating to the digitisation and topics of interest to IAIS.



Some new archival collections have recently been, or an in the process of being, acquired by Special Collections, including the Kutschera photo-archive containing over 100,000 photographs of Kurdistan and the Gulf, as well as other papers, and three archives relating to Jerusalem and Palestine.

During the week of 12-16 September, the Arab World Documentation Unit (AWDU) will be moved from the Old Library back up to a newly-refurbished study space in IAIS, where it was previously housed until summer 2012. This will provide an easily accessible reference collection for staff and students of IAIS, and - in addition to some other rearrangements - the new AWDU will also include an expanded Kurdish section to support the research activities of the Centre for Kurdish Studies. The archivist for the Middle East collections, James Downs, is currently also responsible for AWDU and will be available at selected times to help provide support for users of the collections.



# Mapping Africa's Endangered Archaeological Sites and Monuments (MAEASaM) project workshop, Dakar, Senegal May 2022

Our Arcadia funded project, a collaboration with seven other institutions across Africa and Europe, started amid the pandemic in September 2020. We have met on Zoom every week since, but never in person, until Institut Fondamental d'Afrique Noire (IFAN) hosted a workshop in Dakar, Senegal, last month. During our three-day workshop we celebrated our current achievements, including mapping over 22,000 archaeological sites across our eight African countries only using satellite images and legacy records. We also deliberated on our forthcoming fieldwork and how we will capture sites on the ground. Overall, it was a very successful three days and we were lucky enough to visit Goree Island and the new Musée des Civilisations Noires (both photographed). Over 8-9 July, IAIS joined the Exeter's Global Systems Institute (GSI), Radical Ecology, the Serpentine Galleries, Open Society Foundations, UCL's Sarah Parker Remond Centre for the Study of Race and Racialisation (SPRC), and other sponsors in hosting 'Equilibrium: A Public Gathering on Environmental Justice' in London. This two-day event began with a closed workshop titled 'Towards a New Global Architecture for Climate Finance', during which Katie Natanel facilitated discussions with participants from the International Centre for Climate Change and Development, Climate Vulnerable Forum, GSI, Stop Ecocide International, Global Alliance for a Green New Deal, among others. Following the workshop, a public event took place at the Serpentine Galleries, where interdisciplinary artists, campaigners and thinkers gathered to address the role of culture in creating and supporting environmental justice.

This generative collaboration continues in September, when Katie will be joining Ashish Ghadiali (GSI, Radical Ecology), Ruth Potts (Senior Advisor, Green New Deal Group) and Iman Datoo (Visual Artist) in facilitating a gathering of the <u>Black Atlantic Innovation Network</u> (BAIN) in St. Austell, Cornwall. The meeting brings together representatives of SPRC, UCL Critical Heritage, the National Trust, the National Education Union, Serpentine Galleries, Tomorrow's Warriors, the Young Vic, Eden Project, the Royal Botanical Gardens, the Nicoletta Fiorucci Foundation and Lankelly Chase. Through movement workshops, musical performances and dialogue sessions, we will engage with issues relating to the network's core mission and future activities.

#### 18. Professor Christine Robins

Our AHRC-funded project, <u>Sinjar Lives</u>: Oral Histories from the IDP Camps of Northern Iraq, has now finished its collection phase.

A community-led initiative, the project focused on collecting oral traditions and memories whose context and transmission have been ruptured by the genocide of the Êzidis (Yazidis) of Mt Sinjar (known as Shingal, in Northern Iraq) at the hands of ISIS/Da'esh in 2014. Most of this community is now displaced, in camps in Northern Iraq or scattered as refugees across the world. This grant was originally formulated as a GCRF urgency project. We are very grateful that when the GCRF funding was reallocated as Covid struck in 2020, the AHRC took up the funding instead and we were able to go ahead.

Currently, the project leaders - Zêdan Xelef and Emad Bashar, along with a team of Êzidi oral historians, are preparing about 80 oral history interviews for archiving and you can follow their progress via @tewtewarchive on Instagram, Twitter or Facebook. 'Tew Tew!' means 'Bravo!'/ 'Well sung!'/'Great job!' in Kurmanji (Northern Kurdish), the Shingali Êzidis' mother tongue.

This summer we hosted a series of Zoom seminars through June. Called the Tew Tew seminars, they aimed to introduce Êzidi to some of the most recent scholarship on Êzidi history and culture, to which many of them had not previously had access.

Prior to this, the in-country project team organised a folklore festival in the Lalesh Valley, Iraq on 29 April. Singers and tellers performed in intimate spaces in a joyous celebration of Êzidi oral tradition.

Along with the Principal investigator Christine Robins and Co-investigator Alana Marie Levinson-LaBrosse, Zêdan and Emad have collaborated on a number of publications for different outlets.

We are excited to announce that our first short article has just appeared in the magazine of the Friends of the Pitt Rivers Museum. It contrasts knowledge production from the 1950s, in the form of photos of Shingal by the British photographer Wilfred Thesiger, with contemporary knowledge production by Shingalis themselves, as they work on cultural preservation in the aftermath of genocide.

#### 19. Dr Emily Selove

The Sorcerer's Handbook project focuses on a collection of magical texts by an influential medieval scholar of the Arabic language, Sirāj al-Dīn al-Sakkākī (d. 1229 CE). Participants are producing an edition and translation of his grimoire, the *Kitab al-Shamil*, accompanied by a coauthored volume of essays. The team met up in person and online this July 18th-19th to discuss topics ranging from Indian and Zoroastrian influences on medieval Arabic magic to modern performance theory as a method to understand ritual. IAIS Senior Lecturer Emily Selove is the Principal Investigator of this Leverhulme-funded project.
